On Thursday, 05 January 2017 at 02:09:18, unit TK12 responded to 4275 STONE MOUNTAIN HWY SW, LILBURN, GA. Upon arrival an unknown type of incident was found.		
Unit TK12 arrived at 00:00:00 with 3 personnel		
The actions taken by this unit were: 51 - Ventilate and 52 - Forcible entry.		
TK12 RFQ on initial dispatch to a fire in a car dealership body shop. Upon arrival TK12 cut chain on security gate at HWY 78 to enter parking lot. TK12 spotted on B/C corner and began forcible entry on door to service bay. After gaining access. TK12 coordinated with fire attack crews to provide ventilation by opening several bay doors on Bravo side with E6. TK12 and E6 then extended aerial to rooftop to create ventilation openings by taking out fiberglass skylights on roof over body shop area. TK12 then placed equipment back in service and returned to service. TK12 cut lock off security gate on Paxton Drive to exit. JAJ

On Thursday, 05 January 2017 at 02:09:18, units E22, M3, E12, FD5, MS1, B2, S20, TK12, TK22, E6, E3, A9, FD11, E2, GSAR2, TRT24, S24, E28, E9 and B1 responded to 4275 STONE MOUNTAIN HWY SW, LILBURN,		

GA 30047. Upon arrival a 111 - Building fire incident was found.

The primary property use is 579 - Motor vehicle or boat sales, services, repair.

Unit E22, the first arriving unit, arrived at 02:13:42. The last unit on scene, E22, cleared the scene at 05:42:31.

Actions taken by the primary responding units were: 81 - Incident command; 86 - Investigate; 112 - Extinguish / Offensive; 11 - Extinguish; 12 - Salvage & overhaul; 21 - Search; 51 - Ventilate and 52 - Forcible entry.

A total of 20 units and 43 personnel responded to this call.

Company 22 responded to a possible fire located at a car dealership with Gwinnett Pd reporting smoke coming from the structure.

Upon arrival Engine 22 found heavy smoke coming from all sides of the structure. Truck 22 arrived on the scene and assumed command from Engine 22.

Engine 22 gained entry though a locked gate, and forced entry into the structure on the "D" side of the structure. Engine 22 deployed 1 1' 3/4" on a wye and made entry into the structure. Engine 22 conducted a left handed search and located an active car fire in the auto repair shop. Engine 22 obtained a knock down on the car fire.

Engine 22 then became low on air supply and notified command and exited the structure.

All exposure are noted in 12 exposure tabs. All vehicle are in order of damage received in the fire. The first vehicle listed was located closest to the fire and with the last vehicle listed being furthest away from the vehicle that started the fire.

Narrative Text: S24 on scene and was assigned to perform a search of the front office portion of the car dealership. S24 performed a primary search and checked for fire extension. Crews found a heavy haze of smoke and performed natural ventilation to the area. A 2nd floor was located and crews waited for key holder to provide access. Primary all clear was given in the assigned area. Crews were able to silence the audible fire alarm.

Narrative Text: Car 5 arrived on scene and met with on scene commander Chief Wolfe. IC advised conditions are improving and fire is under control. Car 5 kept B2 in command. Car 5 contacted radio to have on duty investigator enroute. Car 5 then met with company manager and company owner to show them the damage and explain the situation. Owner advised of items he needed take care of for his business. Car 5 gave owner business card and told him he could call with any questions the next day.		
Title: Battalion 2 Narrative	Type: 3 - Personal	Author: Brian Wolfe
Narrative Text: Upon Battalion 2 arrival, I made entry through the Bravo side gate behind Engine 6 and drove around the business completing a 360 degree assessment of the structure. As I staged my vehicle, I noted increased volume of smoke and began to consider critical factors for a commercial structure. I approached the building to check on heat conditions and placed my bare hand on the C/D side garage door and was unable to keep my hand there greater than 2 second due to the heat in the structure. The fire attack group was making headway on their left hand search but had not reached the seat of the fire and it was still unknown what was on fire. I met face to face with initial IC Captain Joe Schull who had a solid plan in place and in motion. I agreed with his plan and determined that due to potential complexities to divide this incident into Command and Operations sections to prepare for potential long term incident. I requested two additional engines, established an Incident Safety Officer with MS1, requested utilities, requested a fire investigator to respond to the incident and prepared the command center workstation. A short while later, fire attack group consisting of Engine 12 and Engine 22 (with Truck 22C) reached the seat of the fire and it was determined to be a single vehicle fire they were able to bring under control. Operations began to move towards property conservation by ventilating the structure by opening roll up doors after confirming the fire was under control. Roof operations were conducted to ventilate the remaining smoke which could not be removed using forced ventilation. Engine 6 and Truck 12 conducted the roof operations by using a K12 to cut a vent hole for smoke removal. The established RIT team stood down once the IDLH conditions were removed and overhaul operations had begun. Strong coordination and communication enabled the incident to progress smoothly and quickly with a consistent rotation of crews to perform overhaul and reach benchmarks. Additional crews checked the showroom, office and parts department for residual smoke which was removed with natural ventilation and in business ventilation fans. Command worked towards demobilization by returning crews as they rotated through rehab and were cleared to return to work. Engine 2 was released followed by Engine 9, Engine 28, Company 24, Engine 6 and Company 12. Company 22 and Engine 3 remained on scene completing final walkthrough and ensuring the loss stop of the incident. Loss stopped and all remaining units including Battalion 2 returned to service.
